If you would like to use the Tennis Courts, you need to submit this form in order to receive a non-duplicable key for access. The first key is issued to the Villages of Northpointe resident at no charge. If you need additional keys or lose a key, it is a \$10.00 charge per key. Please fill out this form completely and return it to Chaparral Management at the address noted above. You must include a self addressed stamped envelope so the key may be returned to you. Allow 10 days for return. In order to qualify for a court key, you must be homeowner or resident of Villages of Northpointe, whose association fees are in good standing. Please make your check payable to Villages of Northpointe CIA. NO CASH OR CREDIT CARDS. Make a copy of this agreement for your records.

- 1. Operating hours of the tennis courts are 7am – 10pm.
2. No wheeled devices of any kind are permitted on court surface. This includes strollers, wagons, skateboards, roller-blades, bicycles, roller skates, etc.
3. Courts are for residents of the Villages of Northpointe Community and their guests. A key-issued resident or homeowner must accompany all guests during court use.
4. Only shoes designed for play on soft court surfaces are permitted. Shoes must be worn at all times.
5. Parent/guardian/resident will be held accountable for payment to Villages of Northpointe CIA for damages to the facility caused by their children, their guest(s), and/or themselves.
6. Pets, Food, Alcohol and Glass Containers are not permitted in the court area.
7. Smoking or use of other tobacco products is prohibited on the courts.
8. Playing time is limited to (1) hour if other residents are waiting to use the courts.
9. The gates to the tennis courts are to be closed after entering and upon leaving the courts.
10. The last player to leave the courts is expected to turn out the lights and lock the gate.
11. Members or guests violating the rules may have their court privileges suspended.
12. Villages of Northpointe CIA reserves the right to change or modify these rules and regulations as necessary.
13. Tennis court locks may not be re-keyed more than every two years unless circumstances lead otherwise.
